## Virtual 6-Week Safety Manager Boot Camp

The primary elements that define the RBS approach are examined, which address safety policy and procedural design, construction safety, operations safety, and maintenance of an industrial activity safety. Participants primarily from the construction and general industry sectors (as well as other industries) will gain the knowledge to:

- Improve safety management practices;
- Build and operate more effective safety management systems that will fit your company's needs and resources;
- Meet and exceed compliance requirements [Compliance is not enough. UAS' RBS Approach exceeds regulatory requirements and focuses on the risk that is associated with each operation in order to, protect people, property, and the environment.]

This highly interactive, fast-paced virtual course is taught by our senior group of certified safety professionals (CSP), Associate Safety Professional (ASP) and Certified Industrial Hygienist (CIH) each with 25+ years' experience. Lecture, videos, case studies, discussion, and breakout sessions are featured within this virtual program. For selected elements, a workshop, exercise, or discussion follows for participants to analyze the concepts presented and participate in group discussions to facilitate information sharing, understanding, and application of the materials.
